  - Upgrade food at the event.

**Decision:** 2015 Financial Statement accepted as balanced. \$1,500 approved as prudent reserve.

**Action:** Committee members to take back to their groups for discussion what to do with \$ remaining above prudent reserve. To be tabled for decision at next Committee meeting in December.

#### Post meeting notes from the Chair:

As sometimes happens, things "pop into mind" after the meeting. Here are a couple of things that we should consider and talk about at the next committee meeting:

- J.N. will get pricing on 12 Steps and 12 Traditions blinds for the Roundup from the Literature Committee or G.S.O. and present findings to the committee.
- J.N. will contact a member of the Fellowship in this District who does banners and request a quote for a new Roundup banner. The idea is that this banner would have the Roundup logo (That you may have seen on Roundup Letterhead). It would likely be substantially bigger than the current Roundup banner (which is about one foot high by two feet long). J.N. will also get a quote from this person for a banner with the 2016 Roundup theme.
- We forgot to start talking about this next point, so I am going to put it in capitals so you don't miss it: WE NEED TO START PUTTING NAMES FORWARD FOR ROUNDUP SPEAKERS!!!!
  - I will kick things off on this front and make a recommendation for J.L. from the Western part of Ontario. She was a former Area 86 Delegate and was in the running for a Trustee position a year or so ago. I have heard her speak a number of years ago and believe that she has a message that would fit well with our theme of "Recovery". She does live a great distance from D19. Therefore, there would likely be travel and lodging expenses incurred if we decide to invite her.
